One in five people will experience a serious mental illness or substance abuse issue in their lifetime. Mental illness affects the family as a whole - not just the person dealing directly with the issues.

Hailey was less than 6 months old when her father was diagnosed with bipolar disorder, an illness that causes dramatic shifts in mood, energy, thinking and behaviour from mania to depression and back again.

United Way funded agencies provide support to those with mental health concerns. They also support the family members, helping people like Hailey and her mom understand what is happening and how to cope.
